The Philadelphia Freedom Valley YMCA, one of the nation's leading nonprofits for over 160 years, strengthens communities through Youth Development, Healthy Living and Social Responsibility Throughout Southeastern PA, the Philadelphia Freedom Valley YMCA serves nearly 160,000 members and more than 230,000 individuals a year Anchored in 18 locations in Chester, Delaware, Montgomery and Philadelphia counties and a 1,100 acre summer resident camp, Camp Speers in the Poconos, the Y provides programs and services that include Health and Wellness, Aquatics, Child Care and After School programs, Youth Sports Leagues, Summer Day Camp programs, Teen Leadership Clubs and Y Achievers The Philadelphia Freedom Valley YMCA fulfills its non-profit obligations in countless ways through financial assistance subsidies for participation in membership and programs, and through targeted mission-based initiatives that meet the specific needs of individuals and families In addition to membership dues

HEALTHY LIVING The Y is a leading voice on health and well-being We bring families closer together, encourage good health, and foster connections through fitness, sports, fun and shared interests As a result, our more than 160,000 members receive the support, guidance, and resources they need to achieve greater health in spirit, mind and body Our programs are accessible, affordable, and open to all faiths, backgrounds, abilities and income levels In 2015, we provided over \$8.4 million in financial assistance to people who otherwise could not afford the membership We focus our efforts on "health seekers," which we define as children, youth, teens, adults and families whose successful pursuit of health and well-being requires continuously supportive relationships and environments Inside the Y, we influence and motivate health seekers to make positive changes in their pursuit of well-being Outside the Y, we help to create and sustain healthier communities through collaborative partnerships with other community-based health and social service organizations Healthy Living Initiatives and Programs are the Y's response to our nation's growing health crisis The Y is redefining itself and engaging communities across the country to better support Americans of all ages who are struggling to achieve and maintain healthy spirits, minds and bodies for all Membership & Health and Wellness We provide resources and guidance to assist members in maintaining or improving their health and wellness at any stage of life The Y provides a variety of health and wellness programs including group exercise and water fitness classes, health and wellness seminars, educational classes, personalized training programs, non-competitive youth and adult sports leagues and social opportunities for seniors and families The Philadelphia Freedom Valley YMCA ensures that everyone, regardless of income, has the opportunity to participate in all programs and services Through the Annual Campaign in 2015, the YMCA raised over \$6.1 million With these funds, the Y provides quality programs and services and financial assistance to 1-in-4 of our active children and family members Prevention The Y is increasingly focused on helping individuals to prevent or mitigate the adverse effects of chronic health conditions such as type II diabetes and obesity In 2015, we continued to provide the YMCA Diabetes Prevention Program, Y-USA's model program designed to help those at risk of developing the disease to engage in positive nutrition and physical fitness habits Our Y is also a support to cancer survivors in our communities We offer support to breast cancer survivors at the Spring Valley and Phoenixville YMCAs through the Pink Confetti program We adopted Y-USA and the LIVESTRONG Foundation's LIVESTRONG at the YMCA, which was piloted at the Rocky Run YMCA Health Screenings The Philadelphia Freedom Valley YMCA provides health education and screenings for our community throughout the year at all of our locations as well as community events Often provided through partnerships with local hospitals and health systems, health education and screenings include such topics as weight management, stress reduction, smoking cessation classes, nutrition, blood sugar and blood pressure checks and skeletal muscular scans In addition, we provide health and wellness prevention instruction and materials to educate our members on the importance of maintaining good health As service to our members and the overall community, health education and screenings are either provided at low or no cost to the participant Healthy Kids Day Every year the Philadelphia Freedom Valley YMCA participates in the National YMCA of the USA Healthy Kids Day As a leading nonprofit strengthening community through healthy living, the Y holds Healthy Kids Day to teach healthy habits to kids and families to inspire a lifetime love of physical activity Families are encouraged to participate in this event together and take part in the activities, screenings and other learning opportunities With help from local organizations, the Y is able to provide this free event to the community In 2015, approximately 10,954 youth and adults attended our Healthy Kids Day event throughout our Association SPLASH Week Once a year, the Philadelphia Freedom Valley YMCA provides SPLASH Week As a service for the community, SPLASH Week is a FREE program designed to help children and families learn important swimming and water safety skills, develop self-confidence, pride and inner strength Drowning is the leading cause of death for children ages 12 and under In 2015, we served over 1,236 children and families throughout our Association

YOUTH DEVELOPMENT The Philadelphia Freedom Valley YMCA is committed to nurturing the potential of every child and teen We believe that all kids deserve the opportunity to discover who they are and what they can achieve We help young people cultivate the values, skills and relationships that lead to positive behavior, better health, and educational achievement Programs such as Child Care, School Age Care and Summer Day Camp Programs offer a range of experiences that enrich cognitive, social, physical and emotional growth Expenses include subsidies and direct financial assistance that make participation possible for 3,000 kids daily to receive our services We are the largest nonprofit provider of Child Care services in Southeastern PA, caring for over 3,000 children each day We offer state-licensed and Keystone Star ranked child care programs at 18 branch locations and 90 program sites including the Audubon, Abington, Ambler Area, Boyertown, Christian Street, Columbia North, Haverford, Northeast Family, Phoenixville, Pottstown, Rocky Run, Roxborough, Spring Valley, Upper Perkiomen Valley and West Philadelphia YMCAs We offer high-quality Pre-K programs at the Audubon, Columbia North, Northeast Family, Roxborough, Phoenixville and Pottstown YMCAs All of our Child Care programs provide a safe, nurturing environment in which children learn, grow and develop social skills Financial assistance mitigates economic barriers working families face in choosing high-quality care Classrooms are set up by age and our teachers utilize The Creative Curriculum, which assists learning through play The Center Method and The Creative Curriculum are themed-based with specific goals for individual development, preparing each student for higher levels of learning Children also benefit from meaningful physical activity, such as swim lessons and gym activities We work with parents, helping them to build knowledge of early childhood development and education Equipped with this knowledge, parents work diligently with their children to reinforce lessons and skills learned at the YMCA at home Excellent Child Care also hinges upon delivering individualized consideration of the special needs of each student Small classrooms that enable ample personal attention between teachers and students are a hallmark attribute of early childhood education at the Y For children ages 12-24 months, the teacher to student ratio is 1:5 For students 2-5-3 years old, the teacher to student ratio is 1:6 For students 3-5 years old, the teacher to student ratio never exceeds 1:10 Since quality care depends on quality teachers, all of our early childhood education classroom teachers have a minimum of an Associate's degree in Early Childhood Education The Y is committed to professional development and encourages staff to further their education in order to provide the most knowledgeable and experienced care possible Our Child Development Associate Training Program provides an essential credential to an emerging childcare professional This nationally recognized credential assists practitioners in meeting the specific needs of children and gaining the knowledge to work with parents and other adults to support and nurture the physical, social, emotional and intellectual growth in a child development framework In 2015, we graduated 93 individuals with a CDA The Family Childcare Network increases the quality and quantity of infant/toddler care centers in the City of Philadelphia and surrounding counties by providing training and technical assistance to meet the prerequisites for accreditation under National Association of Family Child Care Centers (NAFCC) Any resident of Philadelphia, Montgomery or Delaware County can become a licensed family childcare provider Through our program we assist a minimum of 75 participants, caring for 450 children annually, to attain all required licenses and permits from the City and State in order to legally operate a child care business Once they enter kindergarten, we encourage the social and psychological development of children through state-licensed before and after school care programs Across the entire association in 2015, we served over 1,500 students in grades K-8 with both Before and After-School Programs Monday - Friday, before school care begins at 6:30am or 7:00am, depending on the branch site, and includes transportation to select schools in the branch's local community After school care runs from school dismissal to 6:00pm and also includes transportation from select schools in each branch's neighborhood to the YMCA On early-dismissal days and school holidays, we offer half and full day child care service, ensuring that children spend that time in a safe, nurturing, and structured environment School-Age Child Care provides a setting in which children receive academic assistance that accommodates their personal learning style and needs Homework help and tutoring reinforces the learning accomplished during school hours Our school-age child care programs strive to engage children in productive extracurricular activities that are voluntary and confidence-building Students choose from activities including swimming, arts & crafts, basketball and other sports, and chess instruction Healthy snacks and/or dinner are also available to students Select branches, such as the Columbia North YMCA, offer Middle School Clubs for youth in grades 6-8 Clubs offer swimming, computers, sports and homework/test prep Similar to our other school-age child care programs, Middle School Clubs emphasize character development and the Y's four core values Honesty, Caring, Respect and Responsibility When school is out, quality summer programs reinforce and advance the physical, psychological and social growth of youth In 2015, more than 5,500 youth participated in our Summer Day Camp Programs with 1-in-3 campers receiving financial assistance Y Summer Day Camps focus on character development in a fun and enriching environment offering extracurricular activities that may not be available in school given budget cuts to arts, music, and physical education programs Camp ages 3-16 explore their interests in areas including sports, gymnastics, swimming, theater, dance, art, and community involvement and volunteerism The Y encourages youth to grow their personal interests and strengths while building their social skills, physical health and wellness, and self-confidence All branches offer a variety of age-appropriate summer experiences for children Pre-school camp (Camp Small Feet) introduces children ages 3-5 to nature and science through games and outdoor play, arts & crafts, songs and swimming Traditional Summer Day Camps employ a weekly theme to engage campers in activities ranging from fitness and sports, arts & crafts as well as weekly field trips Specialty sports, gymnastics, theater, dance, and volunteerism/civic engagement camps The Abington, Ambler Area, Spring Valley and Roxborough Ys offer Camp Magic or Camp Outlook These camps are specifically designed for children with Autism, high-functioning ASD, or other special needs and create an environment where special needs children can enjoy all the activities and fun of summer camp Camp Magic and Camp Outlook cater to the unique needs of these children while promoting integration with mainstream campers to enable all children to learn and appreciate other individuals We maintain a ratio of 6:1 campers to staff at pre-school camps and 10:1 for youth ages 6-8 and 12:1 at all other camps We select staff for their experience, problem-solving skills, creative thinking skills, enthusiasm, maturity, and most importantly their love of children All staff must be at least 18 years old to work for the Y Camp Directors must be at least 21 years old, possess a valid driver's license, and have at least three years of supervisory experience To promote safety and preparedness, all camp staff receives a minimum of 40 hours of pre-camp training including First Aid and CPR as well as child abuse prevention All camp staff attend a day-long seminar taught by senior camp staff, consultants from the Redwood Group, Brown and Brown Consulting, and teachers from local Delaware Valley public schools Topics include aquatic safety, behavior management, Active Engagement/Games & Activities, working with 5-12 year olds and Leading a Great Camp Experience In partnership with the PA State Alliance of YMCAs Executive Committee, we participate in the 7th Grade Membership Initiative The 7th Grade Membership Initiative guarantees every 7th grade student in Pennsylvania a free one-year membership, creating an opportunity to engage, cultivate and connect with youth at a time that is most crucial to their development In 2015, we provided over 14,500 7th Grade Memberships valued at over \$1,052,014
