PennDOT contracts - contracts for Alcohol Highway System, LEL, Quality Assurance for Ignition Interlock and Teen Safe Driving. Provide certification and re certification for CRN evaluators and DUI/UAD instructors. Held workshops/conferences for PAHSP for DUI instructor certification and workshops/conferences for CRN evaluator certification. There were miscellaneous continuing education workshops that were held to provide a vast array of materials, products and services for the DUI professional. Under the Quality Assurance program of Ignition Interlock contract, over 1,400 surveys were sent out to participants. For 2015, 262 site inspections were conducted and there were approximately 7,000 participants in the Ignition Interlock program.
