The PAO fulfills its mission by providing education for doctors and their staff, by advocating for ophthalmologists and their patients in the state legislature, and promoting preventative eye care to the citizens of Pennsylvania. Activities that support this mission include: 1. Advocating for passage of SB 795, which defines eye surgery as the practice of medicine. This is a patient safety initiative that ensures only trained medical and osteopathic doctors and surgeons can perform eye surgery in Pennsylvania. The PAO engages a lobbyist and is involved with grassroots efforts to achieve this effort. An Advocacy Day was held in May 2015, in which over 50 ophthalmologists met in Harrisburg to visit their legislators in support of SB 795. 2. The PAO hosted educational activities for ophthalmologists and their staff in anticipation of the implementation of ICD-10 on October 1, 2016. In partnership with the American Academy of Ophthalmology, a series of CodeQuest seminars were held in Pittsburgh, Harrisburg, and two Philadelphia locations. 338 people attended these events. 3. The PAO publishes four newsletters a year on topics relevant to ophthalmologists, including Coding and Reimbursement, Legislative and Regulatory Updates, and Academy News.
