THE INITIATIVE BEGAN IN 2011 WHEN LBBC RECEIVED 3 YEARS OF FUNDING THROUGH A COOPERATIVE AGREEMENT WITH THE U.S. CENTERS FOR DISEASE CONTROL AND PREVENTION TO EXPAND AND STRENGTHEN OUR PROGRAMS FOR YOUNG WOMEN.
