New Market Tax Credit (NMTC) Program. PIDC Community Capital (PIDC CC) serves as the allocatee for the Community Development Financial Institution's NMTC program. The program is designed to generate private sector capital investments in low income areas. During 2015, PIDC CC closed 4 NMTC transactions totalling \$26.5 million of financing to qualified low income businesses.

Small Business Lending. PIDC CC has loan products that provide working capital in the form of a revolving line of credit or term loans to small disadvantaged businesses within Philadelphia. These products target minority and women owned businesses that are unable to obtain financing from traditional lenders. During 2015, PIDC CC closed \$11,925,000 of loans, of which \$2,823,000 and \$7,750,000 was disbursed to women owned and minority owned businesses, respectively.
