THE FOUNDATION RAISED FUNDS, INCLUDING A GRANT RECEIVED IN 2011 FROM THE COMMONWEALTH OF PENNSYLVANIA, DEPARTMENT OF COMMUNITY AND ECONOMIC DEVELOPMENT, IN SUPPORT OF THE NEWLY RESTORED MOUNTED PATROL UNIT. WITH THE ASSISTANCE OF THE FOUNDATION, THE UNIT HAS ADDED SEVERAL HORSES AND OFFICERS. THE FOUNDATION CONTINUED TO PROVIDE FUNDING FOR THE CARE OF THE HORSES (FEED, BOARDING, BEDDING, VET SERVICES), AS WELL AS PURCHASED EQUIPMENT (SADDLES, FACE SHIELDS). THE FOUNDATION PROVIDED FUNDS THAT ALLOWED THE PHILADELPHIA POLICE DEPARTMENT TO PROVIDE POST ACADEMY TRAINING TO THEIR OFFICERS. ADDITIONALLY, THE FOUNDATION PROVIDES FUNDS TO SUPPORT THE DEPARTMENTS K-9 PROGRAM ALONG WITH MOTORCYCLES FOR THE DEPARTMENT. THE FOUNDATION PROVIDES FUNDS FOR NEW BULLET PROOF VESTS, BICYCLE LIGHTS AND OTHER MISCELLANEOUS SAFETY FEATURES FOR THE OFFICERS AS NEEDED OR REQUESTED.
