CONVENTION ACTIVITIES INCLUDE SEMINARS, FIELD TRIPS TO VISIT RAILROADS HISTORICAL RAILROAD SITES, INSPECT RAIL FACILITIES, OBSERVE OPERATION OF PRESERVED RAILROAD EQUIPMENT AND RAIL EXCURSIONS, OFTEN ON RAIL LINES WHICH RARELY HAVE PASSENGER TRAIN SERVICE.
