Goodwill Industries of the Columbia operates donation-based thrift stores that support facility-based vocational job training services to individuals with disabilities and other barriers to employment. Revenues earned from the sale of donated goods supports community employment services, helping individuals with disabilities, welfare recipients, ex-offenders, and other underserved populations seeking assistance to obtain community employment. Goodwill operates a nine-store retail network that includes e-commerce online sales, and a multi-product recycling program that keeps salvageable items from going into our local landfills.

4b (Code) (Expenses \$ 2,583,802 including grants of \$ 29,041) (Revenue \$ 1,757,454)

The goal of Goodwill Industries is to assist and support individuals with barriers to employment to achieve employment. Goodwill provides individualized job training services to persons with significant disabilities in our retail stores. Individuals served in the retail stores may graduate to community employment services. Individuals served in community employment programs receive pre-employment job-readiness classroom instruction, individualized case management, job development, and retention services. Individuals with disabilities receive job coaching and long-term retention services. Goodwill connects qualified job candidates to employment opportunities in our local community.
