ALTHOUGH THE PUBLIC SUPPORT PERCENTAGE IS LESS THAN ONE THIRD FOR THIS YEAR, RETINA RESEARCH FOUNDATION BELIEVES THAT IT IS IN COMPLIANCE WITH THE INTERNAL REVENUE CODE REGULATIONS. RETINA RESEARCH FOUNDATION HAS BEEN IN EXISTENCE FOR CLOSE TO FORTY YEARS. DURING THAT TIME, THE FOUNDATION HAS CONSISTENTLY MET THE PUBLIC SUPPORT TEST. IT IS ONLY DURING THE LAST FEW YEARS THAT THE FOUNDATION HAS FALLEN BELOW THE ONE THIRD SUPPORT TEST. THE PRIMARY REASON FOR THE DROP IN THE PUBLIC SUPPORT PERCENTAGE IS THE TRANSFER OF FUNDS FROM THEIR SUPPORT ORGANIZATION, THE RETINA RESEARCH PERMANENT ENDOWMENT FUND. THE ENDOWMENT FUND HAS CONTINUED TO INCREASE IN SIZE DUE TO PRIOR TRANSFERS OF PUBLIC SUPPORT FROM THE FOUNDATION AND PUBLIC DONATIONS MADE DIRECTLY TO THE ENDOWMENT FUND. AS A RESULT, IN RECENT YEARS THE FOUNDATION HAS BEEN ABLE TO DRAW ON THE PREVIOUS PUBLIC CONTRIBUTIONS PROVIDED TO THE FOUNDATION AND THE ENDOWMENT FUND. THE FOUNDATION DOES CONTINUE TO ACTIVELY SEEK ADDITIONAL FINANCIAL SUPPORT FROM THE PUBLIC. HOWEVER, THE CURRENT ECONOMIC CONDITIONS HAVE MADE IT DIFFICULT TO ACQUIRE FUNDS THAT MATCH THE SUPPORT FROM THE ENDOWMENT FUND. THE FOUNDATION'S MANAGING BOARD OF DIRECTORS HAS TWENTY-TWO MEMBERS AND IS REPRESENTATIVE OF BROAD PUBLIC INTERESTS RATHER THAN THOSE OF MAJOR CONTRIBUTORS. IN ADDITION, THE FOUNDATION HAS A LARGE BOARD OF ADVISORY TRUSTEES AND SCIENTIFIC ADVISORS WHICH PROVIDE ADDITIONAL ASSISTANCE ON HOW THESE FUNDS CAN BEST BE USED TO SERVE THE PUBLIC INTERESTS. FINALLY, AS NOTED BY THE TAX EXEMPT PURPOSE ACHIEVEMENTS, THE RETINA RESEARCH FOUNDATION SUPPORTS PROGRAMS WHICH HAVE BROAD APPEAL TO THE GENERAL PUBLIC. FOR ALL OF THE ABOVE REASONS, WE BELIEVE THE FOUNDATION MEETS THE FACTS AND CIRCUMSTANCES EXCEPTION FOR THE PUBLIC SUPPORT TEST.
