There are two meetings each year, immediately preceding, and in the same location as the annual meeting and the mid-year meeting of the American Bar Association (ABA). Each meeting lasts for approximately one and one-half days and consists of speakers, panel discussions, and small group discussion, directed toward an appropriate and relevant learning experience for all attendees.
