

Twice each year, Fr. Baumgartner Knights of Columbus Council No. 5452, in conjunction with Knights of Columbus Councils across the State of Michigan conduct fund raising (the MI or Tootsie Roll Drives) to raise funds to assist mentally impaired persons. The only expenses of this fund raiser are the cost of the Tootsie rolls and supplies. In 2015, the spring and fall drives raised a gross amount of (\$19,708). The cost of the Tootsie rolls and supplies was \$669. The remaining \$19,039 was donated to various organizations that assist mentally impaired individuals.
