 Transportation (21%) Transportation Services are provided Monday through Friday, with some recreation trips on evenings and weekends A total of 402,118 revenue miles were provided, resulting in 49,170 trips to 1,484 seniors The trips provide rides to medical appointments, grocery shopping, recreational activities and for other personal needs For this period, 58% of the rides provided required assistance or special transportation There were 19,526 hours donated by volunteers in conjunction with providing rides

**4b** (Code ) (Expenses \$ 1,996,931 including grants of \$ 487,355 ) (Revenue \$ 458,889 )  
 Nutrition Services (43%) This area is comprised of the Golden Circle Nutrition Program, Meal on Wheels Program, Home Delivered Meals and the Food Pantry Programs The Golden Circle program provides congregate meals to seniors in our community at 22 different meal sites Meals are delivered daily to the various sites This program allows seniors to visit with others and receive hot nutritious meals Monday through Friday During this period 2,170 seniors were served a total of 108,484 meals Volunteers provided 32,167 hours of donated time serving food and managing meal sites, which includes receiving the food, serving and cleaning The Meals on Wheels program delivers hot nutritious meals to homes of seniors who are unable to prepare meals for themselves This program provides nutritional support along with social contact with caring members of our community During this period 561 seniors were served a total of 64,506 meals Volunteers provided 11,207 hours helping to prepare meals, delivering meals and visiting seniors The home delivered meal program provides nutritional support to seniors who are homebound or geographically isolated This program also provides social contact with caring members of our community During this period 28 seniors were served 1739 meals Volunteers provided 112 hours helping to prepare meals, delivering meals and visiting seniors This program started in October 2015 The Food Pantry works closely with Care and Share and the federal food programs to provide food to low income seniors in our community During 2015, Silver Key administered two Federal food programs, the Commodity Supplemental Food Program (CSFP) and The Emergency Food Assistance Program (TEFAP) Seniors who are homebound receive their commodities through our home delivery services Silver Key also operated a food pantry to distribute emergency food, food for clients with dietary restrictions, and supplemental food to the federal programs These services are provided with sensitivity, compassion and respect to allow for dignity for those older individuals who must rely on others for their basic needs We work closely with Care and Share to ensure our clients have access to as much fresh produce and dairy products as available A total of 1,421 clients were served, receiving 41 pantry bags, 8,038 CSFP food boxes, 15,339 TEFAP bags and 173 emergency pantry food bags A total of 998 hours were donated in conjunction with assisting seniors receive food pantry items and food drives

 Case Management Services (13%) This area is comprised of Referrals and Information, Case Management, and Guardianship The Guardianship program assists seniors who are deemed to no longer be able to make decisions for themselves During 2015, Silver Key was legal guardian for 44 individuals, and maintained POA for ten (10) individuals Silver Key Case Managers oversee all aspects of these seniors' lives in regards to their health, housing, psychosocial and financial needs This service is often provided through the remainder of their life Most of these seniors are on Medicaid and Social Security that pays for nursing home care and a small stipend for personal needs There are no extra funds to pay guardianship fees so these services are provided at no cost to these clients No other agency in our community provides this service to these low income individuals The Case Managers assist seniors in resolving issues related to Medicaid enrollment and other benefits, finding affordable housing, utilities assistance, and other health and welfare needs During 2015, Silver Key Case Managers saw 1,286 seniors Need based financial assistance was provided to 379 individuals Without intervention, many of these seniors would be in shelters, hospitals, and costly nursing facilities A total of 2,105 hours of service were donated in Case Management during this period
