The majority of our work this year was for nonprofits. 82% of our services were provided for affordable multi family projects and 13% was for small community facilities including childcare renovations, a family service center, two senior centers, a day center for persons with traumatic brain injury, and community centers. 93% of our projects included complete architectural services for nonprofits and approximately 4% of our work included feasibility studies and no cost design services for non profits. The remaining 3% of our work was with public housing authorities, City of Seattle Community Development Dept and the Seattle School District
