IN LIGHT OF THE SIZE OF THE ORGANIZATION AND THE FACT THAT THERE ARE NO EMPLOYEES, IT DOES NOT BELIEVE THAT IT IS NECESSARY FOR A WHISTLEBLOWER POLICY AT THIS TIME. THE BOARD WILL CONTINUE TO EVALUATE ANNUALLY THE NEED FOR SUCH A POLICY AND DOCUMENT ITS CONCLUSION IN BOARD MINUTES.

FORM 990, PART VI, SECTION B, QUESTION 14-DOCUMENT RETENTION/DESTRUCTION AT THIS TIME, THE ORGANIZATION DOES NOT HAVE A COMPREHENSIVE DOCUMENT RETENTION AND DESTRUCTION POLICY. HOWEVER, THE ORGANIZATION DOES PERMANENTLY MAINTAIN ORIGINAL COPIES OF ARTICLES AND BY-LAWS, IRS APPROVALS AND SECRETARY OF STATE FILINGS. COPIES OF PRIOR YEAR FORM 990'S ARE MAINTAINED FOR 10 YEARS.

THE ORGANIZATION WILL BE TAKING A FURTHER LOOK AT ADOPTING A POLICY THAT APPROPRIATELY ADDRESSES THE ISSUES OF DOCUMENT RETENTION AND DESTRUCTION FOR AN ORGANIZATION OF ITS SIZE AND COMPLEXITY.
