OUR MOVEMENT IS INSPIRED DAILY BY THE ACHIEVEMENTS OF OUR ATHLETES ON AND OFF THE PLAYING FIELD. LOS ANGELES WAS HOST TO 6,500 SPECIAL OLYMPICS ATHLETES FROM 165 NATIONS COMPETING IN 25 OLYMPIC-TYPE SPORTS. IT WAS A WORLD STAGE FOR OUR ATHLETES TO DEMONSTRATE ON THE PLAYING FIELD THEIR COURAGE, DETERMINATION AND SPIRIT OF SPORTSMANSHIP. PROJECT UNIFY USES SPORTS AND EDUCATION TO ACTIVATE YOUTH TO SERVE AS AGENTS OF CHANGE, FOSTERING RESPECT, DIGNITY AND ADVOCACY FOR PEOPLE WITH INTELLECTUAL DISABILITIES. STUDENTS WITH AND WITHOUT INTELLECTUAL DISABILITIES TRAIN, COMPETE, WORK AND SOCIALIZE TOGETHER TO BUILD INCLUSIVE SCHOOL COMMUNITIES. STUDENTS, EDUCATORS, ADMINISTRATORS AND FAMILIES RECOGNIZE THE IMPACT OF OFFERING INCLUSIVE OPPORTUNITIES FOR THOSE WITH AND WITHOUT DISABILITIES, AND VALUE THE RESPECT FOR OTHERS AND INCREASED SELF-CONFIDENCE DEMONSTRATED BY STUDENTS WHO PARTICIPATE.
