

- Provide administrative services for donors making deferred gifts to their church or a church related mission or ministry.

Legacy Grants:

The Foundation acts as trustee and administers funds for the benefit of local churches and church related ministries and missions. It manages and administers endowment funds of the Foundation and distributes earnings. It evaluates grant requests, selects qualified recipients, and makes disbursements to qualified recipients. In general it supports the church's evangelical and social service programs, aims, and purposes of the United Methodist denomination in Indiana.

Loan & Savings Ministry:
