

Applicants are prioritized according to the selection criteria, and up to ten awards may be made each year. The Division also gives eight (\$1k) Junior Faculty Excellence Awards. The eight Junior Faculty Awardees (four per meeting) are awarded on the basis of their being tenure-track, junior faculty with excellent emerging research programs as determined by a panel of judges selected by the Executive Committee of the ACS Division of Computers in Chemistry.
