Mothers Empowered (ME) provides free medical care and prenatal and parenting education to pregnant women in need, ages 11-23. ME is a partnership of Good Samaritan Hospital Foundation and two area service organizations. Lifestages-Samantan Centers for Women and Catholic Social Services of the Miami Valley. Through group prenatal care, the mothers meet in small groups of women with similar due dates to learn to care for themselves and their baby, complete regular pregnancy check-ups, and form a support network with other young mothers. Further support is provided through a 24-month post-partum program that provides child development education, counseling and referrals.

The foundation supports many educational programs. These include brochures and seminars for the community, scholarships for employees, certification programs, seminars, conferences and lectures for employees, physicians and community members.

The patient assistance program of the Samantan Breast Center helps those struggling to pay for the basic necessities during their breast cancer treatment. Often, these patients find themselves worrying about how to pay a bill, rather than focus on following their treatment plan. Assistance with paying bills such as rent, utilities, food, transportation, prescriptions and medical fees, allows them to focus on their health and decreasing stress. The Sharing Our Strength (SOS) Support Group, allows patients to share their stories, concerns and questions about their journey. They learn from each other and share their strength to help make the journey easier.

The "categories" of permanently restricted endowments are as follows: to fund the Foundation operations (39%), To support Good Samaritan Hospital's Homeless Clinic operations (27%), To benefit specific programs for a Samaritan Health Partner's affiliate (13%), To provide educational programs for cancer patients (6%), and miscellaneous (15%). Temporary endowments are funds in which all or part of the principal may be expended only after the expiration of a stated period of time or occurrence of a specified event, depending on the donor's wishes. Earnings from temporarily restricted endowments can be either unrestricted or restricted. The GSHF uses the temporarily restricted endowments for the intended purpose set up by the donor, only after the period of time or specified event set by the donor has been met. Part X, Line 2. The following footnote is from the audited combined financial statements for Premier Health and affiliates: Samaritan Health Partners (SHP) is the parent organization of Good Samaritan Hospital Foundation-Dayton (GSHF). Premier Health (Premier), MedAmerica Health Systems (MAHS), Atrium Health System (AHS), and UVMC have been determined by the Internal Revenue Service to be tax-exempt nonprofit corporations and public charities under Sections 501(c)(3) and 509(a), respectively, of the Internal Revenue Code. Samaritan Health Partners (SHP) is tax-exempt under Section 501(c)(3) and is a public charity by reason of being included in the group ruling issued to the U.S. Catholic Church. As tax-exempt organizations, their income is exempt from federal income tax except to the extent of any unrelated business activities. PREMIER, MAHS, SHP, AHS, AND UVMC ALSO OWN OR CONTROL CERTAIN SUBSIDIARIES, WHICH ARE FOR PROFIT CORPORATIONS SUBJECT TO FEDERAL INCOME TAXES. Taxes payable at December 31, 2015 and 2014 for such unrelated business activities are not significant. Management annually reviews its tax positions and has determined that there are no material uncertain tax positions.
