Clinic Services Napa Humanes professional veterinary team is dedicated to ending pet overpopulation. We operate a low-cost, high quality Spay/Neuter Clinic serving companion animals throughout the Napa Valley performing an average of 20 spay or neuter surgeries each day with our one surgery suite operating an average of 250 days. Additionally, Napa Humane is an important link in keeping a healthy population of pets and people by holding a weekly affordable vaccination/microchipping clinic. In our 3.5 hour weekly vaccination clinic in 2015 we vaccinated 2,494 pets and microchipped 1,581 companion animals.

Humane Education Our outreach efforts engage hearts, hands, and minds for animals. We are in classrooms each week of the school year with programs such as Responsible Pet Care and Safe with Cats and Dogs. We have also created a live puppet performance, The Right Pet for Princess Penny, presented in assembly format of 200-400 children per show and provide a curriculum-based activity book to each child to reinforce the humane lessons presented. We sponsor annual subscriptions to KIND News (Kids in Nature's Defense) to over 100 classrooms reaching 3,000 students. And, we offer community classes: Introducing Your Pet to your New Baby and Pet First Aid.

Shelter Support Services We are at the heart of helping homeless animals in our community in the Napa County Animal Shelter by enriching their time while in the Shelter's care and working to shorten their length of stay. We use our Mobile Adoption Unit to take animals from the Shelter out into the community and we help to re-home Shelter pets by leading a cadre of volunteer photographers to take appealing pictures of the animals that show their personalities outside of their caged environment and posting the photos on websites such as Petfinder.com to create the most exposure possible for a pet in need of a home.
