MANAGEMENT WORKED WITH THE AUDITOR'S FIRM TO ACHIEVE A PRELIMINARY AUDIT REPORT, WHICH WAS PRESENTED BY THE AUDITORS TO THE FINANCE AND AUDIT COMMITTEE. THE FINANCE AND AUDIT COMMITTEE REVIEWED THE PRELIMINARY REPORT WITH THE AUDIT FIRM, THEN RECOMMENDED ACCEPTANCE OF THE AUDIT REPORT. THE AUDITORS ALSO MET WITH THE BOARD OF TRUSTEES WHO REVIEWED AND ACCEPTED THE REPORT. AN OPPORTUNITY WAS PROVIDED TO THE COMMITTEE AND THE BOARD TO MEET WITH THE AUDITORS OUTSIDE THE PRESENCE OF STAFF.
