TRANSPLANT PATIENTS THE ORGANIZATION HAS A COMMUNITY-BASED BOARD OF DIRECTORS THAT SETS POLICY FOR THE ORGANIZATION AND IS COMPOSED OF HOSPITAL EXECUTIVES, PHYSICIANS, DONOR FAMILY MEMBERS, AND OTHER TO REPAIR INJURIES IN 2015, THROUGH THE GENEROSITY OF DONORS AND THEIR FAMILIES, WE HELPED RESTORE SIGHT, TREAT DISEASE, AND EXTEND LIFE FOR HUNDREDS OF PEOPLE OVER 1,500 TISSUE DONORS PROVIDED BONE THIS INFORMATION SUMMARIZES CRITICAL TOPICS AND CLEARLY IDENTIFIES MID-AMERICA TRANSPLANT'S ROLE AS A PROCUREMENT ORGANIZATION AND ASSISTS WITH GETTING THE MESSAGE OF ORGAN AND TISSUE DONATION TO PROGRAMS AND ADVANCEMENTS IN ORGAN AND TISSUE DONATION AND 16 NURSING SCHOLARSHIPS TO SUPPORT STUDENTS PURSUING CRITICAL CARE NURSING CAREERS IN ST LOUIS AND SPRINGFIELD, MISSOURI THE FOUNDATION ALSO
