Explanation: Due to the busy schedule of the responsible filing officer and to lower the profile of this organization's mission in India, we filed for an extension of the due date of this Form 990-EZ form. There had never before been a need to extend. The Indian grantee of this Friends organization was engaged in an audit by the Indian federal government of that organization's finances. When that organization ultimately passed with flying colors, this American Friends organization's filing officer did not think to promptly finish the 2015 filing. This situation has never before arisen, and will not be repeated. For example, the 2016 Return will be filed within a week, more than 2 weeks before that return is due.
