HTC OF NEVADA IS PART OF A REGIONAL NETWORK OF OVER 130 TREATMENT CENTERS IN THE NATION THAT SPECIALIZE IN PROVIDING INDIVIDUAL SERVICES TO CHILDREN AND ADULTS WITH INHERITED BLEEDING DISORDERS. HEMOPHILIA TREATMENT CENTERS IN THIS NETWORK ABIDE BY FEDERAL GUIDELINES FOR THE DELIVERY OF COMPREHENSIVE HEMOPHILIA SERVICES AS DEVELOPED BY THE MATERNAL CHILD HEALTH BUREAU (MCHB), CENTERS FOR DISEASE CONTROL AND PREVENTION (CDC) AND THE NATIONAL HEMOPHILIA FOUNDATION (NHF).
