In 2015, The Food Basket again increased overall number of persons served. From an average of 10,000 clients served in 2014, The Food Basket served an average of 12,000 unduplicated individuals per month over the course of the 2015 year. The agency's most significant accomplishments began the process of improving services to indigent residents by seeking several key enhancements to core activities. 1. The Food Basket was able to acquire SNAP Outreach services, a service that allows increased efficiency to our existing outreach program. 2. The Food Basket continued to work on increasing access to food and the variety of client diets by introducing two incentive programs that double the buying power of participants' SNAP dollars. 3. The Food Basket initiated a 600,000 Capital Campaign to replace the aged Kona warehouse. These enhancements sought to provide a more centralized location for deliveries and pick-ups, more cold and frozen storage capacity, and the adoption of new racking and shelving technology for more efficient use of the warehouse footprint.
