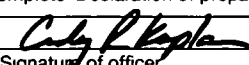

SPOON's mission is to transform nutrition and feeding practices for children living without permanent families and those with disabilities so they may grow and develop to their full potential. We seek to: a) give as many of these children the chance for healthy development, b) influence nutrition policies and procedures around the world, and c) ensure that adopted children get the nutrition they need once they come home.

Nutrition and Feeding: In 2015 we deepened our work in Russia and China, increased our reach in India and Vietnam. We also laid the groundwork to expand programs in Bulgaria, Mongolia, Ethiopia and Zambia in 2016. Through a partnership with Holt International we significantly deepened the Orphan Nutrition Program at Holt sites in China, Vietnam and India. Of special note, in India we recorded an 18-month progression of reductions in anemia from 40% to 0%; stunting from 77% to 45%; and wasting from 22% to 9% over an 18-month period.

We returned to Russia for a follow up training through established local partners.

4b (Code:) (Expenses \$ 36,204 including grants of \$) (Revenue \$ 0)
Oregon Foster Care: SPOON launched the Nourishing Oregon's Foster Children project in January 2015 in collaboration with Department of Human Services and University of Oregon (UO) to offer a tailored nutrition and feeding training program for the foster care community (foster parents, biological (bio) parents, child welfare professionals, and training service providers). Lane County was selected as the initial pilot location for in-person, classroom training as it has the second highest number of foster children (1,100) among Oregon counties, low foster family turnover, a diverse ethnic and age demographic among foster parents, and it has a history of implementing innovative programs through their local DHS office. The project objectives include 1) Needs Assessment, 2) Curriculum Design and Implementation, 3) Training Implementation and Evaluation, and 4) Sustainability and Scale. Needs Assessment was completed in 2015, Curriculum Design was begun in 2015 and will conclude in 2016, Training Implementation and Evaluation will occur during Q1 and Q2 of 2016, and Sustainability and Scale are slated to take place in Q3 and Q4 of 2016, and throughout 2017.

Tools Optimization:
SPOON's Tools Optimization is increasing our ability to deliver our main asset – a proprietary set of solutions to improve the health of vulnerable children – to a broader community, in a more efficient and effective manner, while safeguarding the asset's integrity and quality. The project will integrate and digitize our tools, allowing us to increase their functionality and to automate them into one comprehensive package. The new package will uniquely address multiple nutrition-related risk factors as well as improper feeding techniques for all children, including children with disabilities. In 2015, SPOON launched the design and building phases of the project; hired a technical program manager to run the project; and hired a feeding specialist to provide content.
