Unique aspects of the program include: direct social instructions; sensory supports; visual strategies; positive behavioral supports; involvement of graduate and doctoral students; peer models; ropes course and/or zipline; traditional camp activities, such as horseback riding, archery, fishing swimming, hayrides, art activities, and singing around the campfire; and activities tailored to the individual campers' interests.
