The personal finance classroom resource is provided free to any Wisconsin public high school that requests it. In 2015, 15,415 copies of personal finance publication were distributed to students in 292 Wisconsin high schools by 388 teachers. The program was discontinued in June 2015 when the current contract ended. Other financial literacy and educational opportunities were researched during the second half of 2015, with the intention to roll out a new financial literacy initiative in early 2016.
