It sends grants to help support hundreds of children at one of its 15 schools in Southeast Asia to receive an education. Grants pay for tuition, books, supplies, transportation, lunches, and uniforms. There are many additional informal programs such as tutoring center to help children excel in their education. Empart USA also provides resources to 15 different Transformation Centers throughout Southeast Asia. Each center trains 20-25 young men or women in a one year residential program.
