Conservation actions to save the Scottish wildcat from Extinction. Direct support to Wildcat Haven in the UK for action to reduce threats to the last remaining Scottish wildcats, the only wild cat present in the UK. The Scottish wildcat is threatened with extinction primarily due to interbreeding with feral cats. The program lce catches feral cats, neuters them, and turns them over to a charity for placement.

Direct support to create new small wild cat conservation projects globally by partnering with the Mohamed bin Zayed Species Conservation Fund.

4c (Code:) (Expenses \$ **17,760.48** including grants of \$) (Revenue \$)

SWCCF's fishing cat project in Sri Lanka is reducing threats to fishing cats. A captive enclouse was constructed to house fishing cats that are injured by vehicles. Those fishing cats that can be released are held until they recover, and then released. There are two fishing cats that are severely injured and cannot be released.
