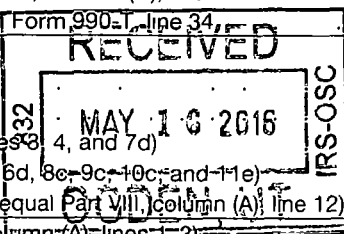

The amount \$ 206,499.00 was already distributed in 2015.

MoeMaKa had received a grant from Omidyar Network Fund, based in California to support the purpose of Open Myanmar Initiative based in Burma, also known as Myanmar. The mission of the Open Myanmar Initiative is to "pull down the wall of ignorance" in Myanmar. The fund is for its parliamentary monitoring work, for two-year period. The amount of \$100,000 was already delivered to the designee in the first year, 2015.

Burmese Helping Burmese - Supporting Burmese Flood Victims with material and aid assistance when it was hit in August 2015. The amount 84,000.00 from public donation was used for this program.
All total amount together - \$ 110,000.00 was already distributed in year 2015.
