The guidance on accounting for uncertainty in income taxes also addresses de-recognition, classification, interest and penalties on income taxes, and accounting in interim periods. Management evaluated the Coalitions tax positions and concluded that the Coalition had taken no uncertain tax positions that require adjustment to the financial statements to comply with the provisions of this guidance.
