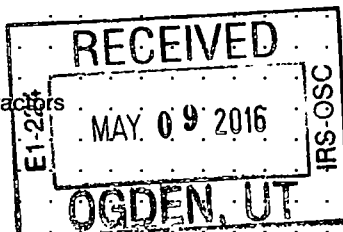

FORU supports ongoing physical therapy services provided by Dr. Brooke Riley, PT, DPT; Dr. Bethany Wolf, PT, DPT; Dr. Larry Devinney, PT, DPT; and other volunteer therapists in rural Jamaica. Services include outpatient therapy and home care in St. Elizabeth Parish. In 2015, the FORU staff completed a total of 1,253 patient visits at Vincent Strambi Health Center and 64 home visits throughout St. Elizabeth Parish. In November/December 2015, the FORU therapy team hosted three PT students from Arcadia University for a five week clinical internship. In 2015, FORU ran five stroke camps in February, March, May, September and December. The camps consisted of five full days of intensive neurological rehabilitation as patients worked to improve their balance, gait and arm/hand function. Pre/post testing was completed on the first and last day of camp to measure functional changes in these areas. One hundred US/Jamaican volunteer physical therapists and physical therapy students from six different universities participated in the camps. A total of 41 patients were served, all of which made dramatic gains in their functional mobility. FORU also hosted thirteen other US volunteers throughout the year to assist with our ongoing programs. This volunteer program serves to further our exempt purposes by supporting charitable medical services to under-served populations and by providing opportunities for volunteers to be involved in improving the quality of life for those living in under-served areas. Our objective of improving the quality of life of the people we serve was met by improving their functional mobility and helping them to become more independent with their activities of daily living. Our long term goal is to reduce the incidence of stroke in Jamaica through raising awareness and providing health education to the public. In the future, we also hope to provide more comprehensive rehabilitation services including speech and occupational therapy as well as nutrition education and counseling.

**PART 111 LINE 29 - READING CAMP**

In July/August of 2015 FORU partnered with its sister organization, FORU Jamaica to help support the seventh annual summer Reading Camp in Ridge, St. Elizabeth. The reading camp was held at the FORU community center four days a week for four weeks from 9 am to 1 pm. The camp continues to be run by local teachers and high school students living in the surrounding communities. PRE/post testing was completed on the first and last day of and children were divided into five classrooms based on their reading level. Each class had one to two teachers and one teacher's aide. To enrich their learning, the children participated in a craft activity each day. Lunch and snacks were provided by FORU for all participants. Local volunteers were provided lunch and paid a small stipend for their assistance. A total of 32 children registered for the camp and of the children who completed the camp 20% showed improvement in their reading scores and the remaining group maintained their current reading level. This program helps to foster a love of reading and to build the children's confidence in their reading ability. Reading Camp also continues to further our goal of eliminating illiteracy in Ridge and the surrounding communities.

FORU assisted a Jamaican high school student with a scholarship for school fees. This student has been a faithful volunteer at reading camp for the last six years. FORU granted its office manager financial assistance towards her college tuition in order for her to work toward completing her bachelor's degree in English. Her passion for teaching began as a high school student volunteer at our summer reading camp. Without this assistance, these highly motivated students would not have been able to continue their studies.
