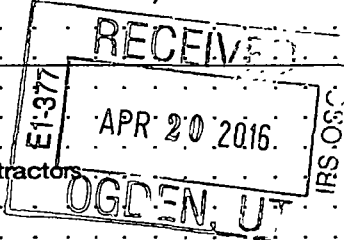



31. Other Program Services include additional mission trips and adventure trips. Creatio organized two additional mission trips to Peru, with thirteen participants serving the poor. Creatio also organized trips to the Philippines, Costa Rica, Ecuador, and the Galapagos. Thirty-three young adults participated in the four trips by serving the poor, encountering God, and building community with one another. Creatio also led pilgrimages in New Mexico and Spain where pilgrims were able to have intense experiences of encounter with beauty and others. Creatio organized several smaller adventure trips around Colorado, which allowed participants to immerse themselves in creation and build relationships with one another on a deep level. Lastly, Creatio hosted a conference on the relationship between faith and the environment that encouraged dialogue between professionals about their field of expertise. Through all these activities, Creatio promotes an integral approach to the human person and encourages growth in each person's relationship with God, himself, others, and creation.
