 Manna Project is an organization that supports a medical clinic in a low income neighborhood just outside the Managua, Nicaragua city dump The clinic provides a general medical care and obstetrics/gynecological services to the impoverished residents of Villa Guadalupe In 2015 the clinic enrolled 1,200 new patients and provided an average of 20 consultations per day It also distributed 89 pairs of free reading glasses to the neighborhood residents
