The note bears no interest, requires 60 monthly payments of \$783 and matures on March 8, 2018. ROHVA shares the vehicle with SVIA and reimburses SVIA \$313 each month for its proportional usage of the vehicle. As of December 31, 2015 the total amount outstanding applicable to ROHVA was \$8,454. ROHVA leases office space in Irvine, California under a noncancelable operating lease agreement, which expires in August 2020 and requires minimum monthly payments of approximately \$21,000. ROHVA shares the office space and related expenses with MSF, SVIA and MIC. ROHVA's pro rata share of the monthly lease payments is approximately \$2,000. In addition to the minimum monthly payments, ROHVA is responsible for its pro rata share of real estate taxes and operating expenses under the lease agreement. The lease agreements contain provisions for base rent increases over the terms of the leases, as well as, increases based on ROHVA's pro rata share of increases in real estate taxes and operating expenses.
