

CBAAs hosts meetings and conferences to facilitate the exchange of ideas, the improvement of pedagogical theory and the celebration of artistic achievements in the Book Arts. See the grants listed above as our main activity. Our 2015 meeting at Scripps hosted 160 participants, and a board retreat. Our total expenses for meetings and programs for 2015 was \$17212.39, this amount included expenses for Scripps meeting, as well as advanced deposits and expenses for the January 2016 Conference in Nashville.
