Leadership Institute: The Leadership Institute is a multi-year partnership between Dignitas and schools designed to equip educators to transform education in their community. It includes four programs in combination to catalyze transformation and sustain development: 1) The Leadership Institute; 2) School-Based Coaching; 3) Professional Development and 4) School Infrastructure Support. In 2015, Dignitas reached over children through teachers in schools across communities in Nairobi, Kenya. Each partner school receives individualized support over three to five years based on periodic evaluations and constant conversations with school staff. Through targeted activities and strategic leadership development in schools, Dignitas seeks to develop in educators the skills, attitudes and beliefs that will transform school staff into leaders who can independently drive school improvements and development.
