FORWARD MONTANA FOUNDATION ENGAGES YOUNG PEOPLE IN THE DEMOCRATIC PROCESS THROUGH LEADERSHIP DEVELOPMENT AND CIVIC EDUCATION. TO ACCOMPLISH THIS MISSION, FORWARD MONTANA FOUNDATION FOCUSES ON NONPARTISAN VOTER REGISTRATION, LEADERSHIP DEVELOPMENT, COMMUNITY BUILDING, AND GET-OUT-THE-VOTE (GOTV) EFFORTS. LEADERSHIP DEVELOPMENT: FORWARD MONTANA FOUNDATION (FMF) GRADUATED 24 INTERNS FROM OUR COLLEGE-AGED EDUCATION PROGRAM AND 6 LEADERS FROM OUR HIGH SCHOOL UNDERAGE DEMOCRACY PROJECT. FMF HOSTED THE FIRST ANNUAL 25 UNDER 25 EVENT RECOGNIZING 25 INSPIRATIONAL YOUNG LEADERS ACROSS THE STATE, WHO WERE SELECTED FROM 110 NOMINATIONS. VOTER REGISTRATION: FMF REGISTERED 2416 MONTANANS TO VOTE THROUGH PEER TO PEER REGISTRATION EFFORTS. THEY ENGAGED 281 UNIQUE VOLUNTEERS ACROSS THE STATE, FILLING 1129 VOLUNTEER SHIFTS WHO CONTRIBUTED TO 2521 HOURS OF OUR WORK. GET OUT THE VOTE: FMF CO-HOSTED STUDENT VOTER DAYS AT THE UNIVERSITY OF MONTANA AND MONTANA STATE UNIVERSITY CAMPUSES, ENCOURAGING STUDENTS TO VOTE IN THE FALL ELECTION. THEY MADE 7,775 ATTEMPTS TO CONTACT VOTERS IN MISSOULA, GALLATIN, AND YELLOWSTONE COUNTIES WITH A NON-PARTISAN MESSAGE ASKING THEM TO VOTE. ISSUE ADVOCACY: FMF LAUNCHED A JOINT ISSUE ID PROJECT ASKING YOUNG PEOPLE WHAT ISSUES THEY CARE ABOUT IN THEIR COMMUNITY. THEY SUPPORTED THEIR SISTER ORGANIZATION, FORWARD MONTANA, IN PROMOTING THE PASSAGE OF TWO SCHOOL BONDS IN MISSOULA COUNTY, THROUGH OUTREACH TO YOUNG PEOPLE.
