4CORE serves Southwest Colorado as the leading resource for the effective and efficient use of energy to promote and sustain vibrant local communities

Describe the organization's program service accomplishments for each of its three largest program services, as measured by expenses. In a clear and concise manner, describe the services provided, the number of persons benefited, and other relevant information for each program title

4CORE accomplished program-specific goals in 2015 in each of their mission-related strategic focus areas, including Energy Efficiency, Resource Efficiency Education, Innovative Solutions and the Energy Information Hub. The Energy Efficiency focus included the Home and Commercial Performance Prescription Programs (HomeRx and CommercialRx) helped residents and business owners save energy and improve health, safety, and comfort in homes and commercial buildings. 4CORE facilitated partner incentives, including the City of Durango, LPEA, Amerigas, and Atmos Energy (under the Energy Smart Colorado label), increasing the number of energy audits and efficiency upgrades. 33 homes and three businesses were assessed in 2015 with a projected annual utility bill savings of \$28,293 and prevention of 94.5 metric tons of greenhouse gases. 4CORE's Innovative Solutions focus area achieved the Solarize Archuleta program, initiated in 2015 which resulted in 13 solar installations for homes and 62 kilowatts of renewable power committed by the end of 2016. A volunteer committee in Pagosa Springs oversaw this campaign under the direction of board members Kurt Schneider and Paul Senecal, which was funded by the Ballantine Foundation and Town of Pagosa and with referral fees paid to 4CORE by three local solar installers. Under Innovative Solutions, we secured an Environmental Justice EPA grant for \$30,000 that initiated the Southwest Solar Barn Raising Program to provide 62 families in low income housing with solar installations that will help offset utility costs at Southwest Horizons Ranch and a Habitat for Humanity home in Bayfield, Colorado. 4CORE also facilitated twelve regional meetings and two working group meetings to discuss alternative fuel vehicles for fleets and provided fleet analyses for six local fleets under the Innovative Solutions focus and the Refuel Colorado grant. 4CORE met with five potential electric vehicle charging stations and successfully oversaw the EV charging at the new Mercury building. This program was supported by La Plata County Energy Council, the Colorado Energy Office, and the Department of Energy through Refuel Colorado. Under 4CORE's Energy Information Hub a newsletter was sent to an average of 1,460 subscribers twice per month. 4CORE also responded to 103 information requests about resource efficiency and continued to update its website with current sector relevant and timely information.
