In 2015, CTKD distributed 6,453 wardrobes and 21,693 pounds of extra items, with nearly 91% of shoppers selecting a complete wardrobe (all 21 non-optional pieces) CTKD increased wardrobe distribution by 43% between 2014 and 2015 and has distributed a total of 26,344 wardrobes since opening in 2008 To be eligible for clothing from CTKD, children must live in the Denver Metro Area or be in foster care, be enrolled in grades preschool-12, or actively pursuing a General Equivalency Degree (GED), and must either be receiving FRL through their school or referred by an authorized person or institution, such as a school employee, religious leader or human service agency In the 10-county Denver Metro Area, more than 190,000 school-age children qualify for FRL In the Denver Public Schools alone, about 69% of students (62,935) were eligible for FRL in 2014-2015
