During calendar year 2015 W2T completed or partially funded more that 121 rural community water projects in Ethiopia, Tanzania & Uganda. These projects include not only the physical construction of the water projects, but also the training of a water council for project and providing water, sanitation and hygiene training for all family units benefiting from the project. The water council is comprised of at least six elected members from the community, half women and half men. The water council is responsible for managing and overseeing the project, including sustainable maintenance by establishing a maintenance fund funded each monty by the family units using the project.
