Marketumbrella works with partners to support local food producers through workshops and knowledge sharing and advocates to ensure local food is accessible and affordable to all.

Crescent City Farmers Market (CCFM) is the hallmark project for Marketumbrella, where staff and local vendors provide a professionally run farmers market four days per week in New Orleans. CCFM ensures that everyone from kids to seniors has access to healthy local food through our programs: Market Match, Farmers Market Prescription Program, Marketeers Club, Meet Me at the Market, and Farmers Market Bingo. The CCFM is instrumental in bringing community together with local food producers as they share information and transact business.
