Scooter's Pals rescues about 300 dogs from high kill shelters every year and helps re-home between one and two hundred more Due to our efforts to find alternative homes, many animals do not reach the shelters We fully vet all our animals (vaccinate, spay or neuter, microchip, and heart worm test and provide monthly heart worm preventative medicine) and home check fosters and adopters so their safety is assured We also provide a limited pet deposit program for those struggling to keep their pets and provide those in need without other options with a refundable (to us not the tenant) pet deposit with the intent of keeping dogs and cats out of shelters Our rescue provides training for dogs with behavior issues and "train" their owners how to best manage these issues for the safety and well being of all Scooter's Pals always takes back our failed adoptions of which there are fewer and fewer and we urge our adopters to make concrete plans for someone reputable and caring to take care of their animals should the adopter become unable to do so We are ALL volunteer pay no salaries and take no personal perks out of our cherished donations
