The organization will operate in a nondiscriminatory fashion without regard to race, gender, national origin, religion, handicap, and sexual preference, however, in awarding scholarships to children it will attempt to focus on underprivileged individuals and to identify suitable underserved and underprivileged candidates and will consider factors such as disabilities, low family income, disadvantaged social or educational environment, and difficult personal and family situations. The goal of the scholarship program will be to provide scholarships that cover part of the cost of tuition, books, and supplies at elementary and secondary schools for needy students.
