Malawi Matters Inc works through the Church of Central Africa Presbyterian (CCAP) Nkhoma Synod. Malawi Matters Inc provides training to the program instructors, lay leaders, church elders, school boards, headmaster and woen's guild leaders who inturn educate their communities. Since its founding Malawai Matters has trained over 2,250 church and community leaders in approximately 250 congregations. These teaching techniques are being utilized to reduce the impact of HIV/AIDS in these communities. Malawi Matters Inc has also expanded it's programing to empower women for life improvement in their communities. Malawi Matters Inc builds relationships; involving everyon in the process of learning and caring for one anohter by including members of the Malawi Parliament, tribal authorities, pastors, denomination leaders, congregation members, city and village citizens, as well as the staff of agencies and organizations that serve Malawi. In 2015 Malawi Matters Inc continued to build a sucessful and ongoing partnership with the Church of Central Africa Presbyterian, which has the reputation for caring and the trust of the people in the country to deliver the training programs to address the negative cultural practices. In 2015 Malawi Matters Inc continued to build local ownership of these training programs and follow up with those groups previously trained to develop better future programs. In February, 2015 the Director of Malawi Matters Inc took part in a HIV/AIDS conference attended by approximately 4,000 community members in Malawi. In 2015 Malawi Matters Inc's programing was attended by individuals and groups representing 178 Malawian congregations with membership of over 1.2 Million adults plus young adults and children.

Part III - Malawi Matter Inc is a 501(c)(3) not-for-profit organization whose mission is to develop and facilitate HIV/ AIDS education with the people of Malawi and Central Africa and to educate Malawian and Central African women for life improvement. By connecting agencies and organizations and using proven hands-on techniques grounded in Malawian culture, Malawi Matter Inc believes that Malawian youth and adults can find solutions to the HIV/AIDS crisis as well as improve and enhance the quality of life in this economically impoverished, but spiritually rich nation. Malawi Matter Inc's expressed goals stress "HIV/AIDS" prevention and life improvement through active, hands-on education utilizing local arts and culture to develop a core group of Malawian trainers to sustain the education programs. Malawi Matter Inc seeks to communicate "why it is vital to learn about HIV/AIDS in all spheres of life" and "why it is important for all citizens to have the opportunity for education and life improvement." Malawi Matter Inc supports on-going efforts to identify methods and skills necessary to address these vital issues. Malawi Matter Inc promotes programs to stimulate creative thinking about these issues among Malawian adults and youth. In 2015 Malawi Matter Inc continued to expand education specically targeted to the empowerment of Malawian female youth.

Part III, Line 28 - Malawi Matter Inc was incorporated in May 2008 and formed a board of Directors in September 2008. The IRS granted Malawi Matter Inc IRC sectin 501(c)(3) status in December 2008. Since then Malawi Matter Inc has continued to work with various Malawian organizations to provide train-the-trainer programs to address HIV/AIDS and life improvement issues in that region of Africa. In 2015 at a total direct programing cost of \$75,236 Malawi Matter Inc trained at 3 sites 750 adult students plus youth and children representing 178 congregations from the CCAP Presbyteries in the central regions of Malawi. Malawi Matter Inc held refresher courses and introductory sessions. Malawi Matters Inc also held programs on life improvement. In 2015 Malawi Matter Inc's Director participated in a HIV/AIDS program in Malawi attended by approximately 4,000 community members.
