JAMAICA (GENERAL): working in cooperation with the Rural Agricultural Development Agency, we supplied approximately 12,025 fruit trees to over 100 recipients in all regions of Jamaica. We also supplied equipment for processing fresh fruit into post-harvest products.

4b (Code:) (Expenses \$ 16,728 including grants of \$ 0) (Revenue \$ 0)
JAMAICA (PRODUCTS): working in cooperation with local partners including the Ministry of Education and Rotary Clubs, we distributed over 2,000 pounds of breadfruit flour to 6 basic schools. The flour is used to make a nutritious breakfast hot cereal to feed young children. This program is pilot to a larger future program potentially involving over 100 schools. This new program is a logical extension of our other programs. This program hopefully will lead to a self-sustaining food production industry.

HAITI: working with local partners including Three Angels Childrens Relief and Smallholder Farmers Association, we supplied over 7,200 fruit trees to farmers. We also distributed over 1,600 pounds of breadfruit flour to 8 schools, orphanages and churches. We also conducted a training session in tree propagation and care in Jamaica for 7 Haitian farmers.
