 SHARE provides respite care for children with special needs and their siblings. SHARE provides care for children with disabilities including, but not limited to children with Autism, Down Syndrome, Cerebral Palsy, and Muscular Dystrophy. Activities are also provided for parents of children with special needs receive a respite from the constant demands of raising a child with a disability. Families enrolled in respite care come from Midland, Ector, Crane, Martin, and Pecos Counties. A total of 2,006 volunteer hours were contributed by approximately 650 volunteers in 2015. The fair market value of these services totaled 49,468. SHARE received donated facilities from local churches valued at 62,828 in 2015.

 Sibshop includes a variety of programs under which siblings ages 6-17 may participate in group discussions with peers and share common joys and concerns. Adult siblings participate mentor the younger siblings. Recreational and social activities are planned so that siblings can develop friendships with other siblings in similar situations. The purpose of these activities is to build a support system for siblings who are often called the forgotten family member. Events are planned which highlight the important role of siblings in families who have children with special needs.
