THAILAND MINISTRY - MAE SOT CHILDRENS HOME CURRENTLY HAS 70 AT-RISK CHILDREN, AGES 3 MONTHS TO 19 YEARS, FOR WHOM WE ASSUME FULL PERSONAL AND FINANCIAL RESPONSIBILITY THIS INCLUDES ALL SCHOOLING, TRANSPORTATION, MEDICAL, FOOD, EXTRA-CURRICULAR ACTIVITIES, PERSONAL HYGIENE, AS WELL AS LIVING AND STAFFING EXPENSES IN THE FALL OF 2015, WE OPENED THE DOORS TO OUR NEW EMERGENCY TRANSITIONAL SAFE HOME THAT IS RECOGNIZED BY THE THAILAND GOVERNMENT!
