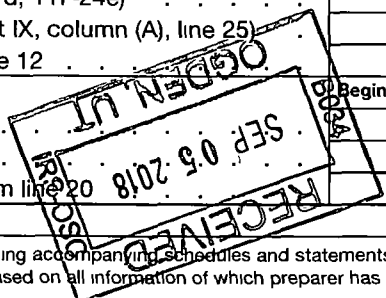

The funded projects addressed a broad range of issues, including water quality, sustainable agriculture, and forest restoration. Our grants are awarded through a competitive RFP process where proposals are reviewed by staff and members of our Impact Circle. Their recommendations are then sent to the Board for additional review and final decision.

All questions and concerns are addressed at the board meeting, after which the 990 and any corrections are approved before transmission to the IRS.

First, in November of each year after the election of new and returning board members, all board members are required to sign the existing conflict of interest policy. Second, in January of each year, a 990 board questionnaire developed by SPF is filled out by all board members to assess independence, per IRS definition, of each board member. Staff and various committee members are also required to complete these two conflict of interest documents.
