DURING 2015 THROUGH THE FORSAKEN CHILDREN'S PARTNERSHIP WITH THE ONESIMUS CHILDREN DEVELOPMENT ASSOCIATION (AN ETHIOPIAN NGO), THE ONESIMUS DROP-IN CENTER FOR STREET CHILD RESTORATION CONTINUED TO BE FUNDED, ALLOWING IT TO CONTINUE OPENING ITS GATES TO COUNTLESS CHILDREN LIVING ON THE STREETS AND THOSE IN DANGER OF JOINING THEM. TFC ESTIMATES THAT APPROX. 2,000 CHILDREN AND ADULTS ARE IMPACTED THROUGH THE DROP-IN CENTER AND OTHER ONESIMUS MINISTRIES EACH YEAR. IN ADDITION TO THE DROP-IN CENTER, THE ORGANIZATION ALSO SUPPORTS AND MAINTAINS TWO HALFWAY HOMES FOR THE CHILDREN WHO ARE UNABLE TO BE REUNITED WITH FAMILY.
